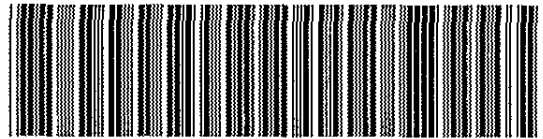

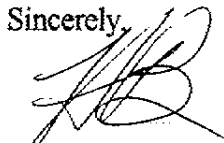

**ARTICLES OF ORGANIZATION**

The undersigned, being a duly authorized representative of the Company, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I: NAME**

The name of the limited liability company is **NT-92 WAREHOUSE, LLC**, (the "Company").

**ARTICLE II: ADDRESS**

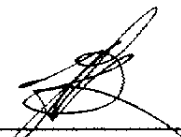
**ARTICLE VIII: MANAGEMENT**

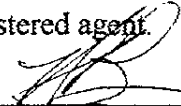
