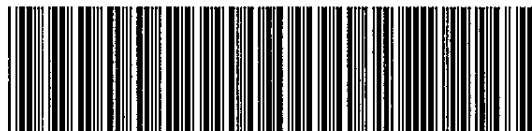

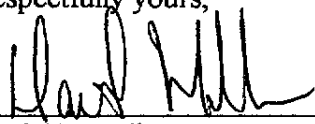

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I. Name

The name of the Limited Liability Company is – **THE MULLAN GROUP LLC**

ARTICLE II. Address

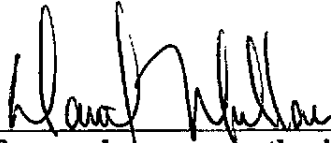
ARTICLE VI. Members Right to Continue Business
