ARTICLES OF ORGANIZATION  
OF

These Articles of Organization are executed and filed with the Florida Department of State to form a limited liability company pursuant to the Florida Limited Liability Company Act (the "Act"):

ARTICLE I. NAME

The name of the limited liability company is **IMPACT PROMOTIONAL PUBLISHING, LLC**

ARTICLE II. ADDRESS

The mailing and street address of the principal office of the limited liability company is 1546 Main Street, Dunedin, Florida 34698.

ARTICLE III. MANAGEMENT OF COMPANY

The business of the limited liability company initially will be managed by a manager, Pink Palace Management, Inc. a Florida corporation, d/b/a Impact Services.
