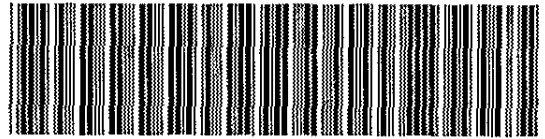

ARTICLES OF ORGANIZATION
FOR
THE SOUTH'S FINEST FLOORING, LLC

ARTICLE I - NAME

The name of this limited liability company shall be **THE SOUTH'S FINEST FLOORING, LLC**.

ARTICLE II - DURATION

This limited liability company shall have perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IX - MEMBERS' RIGHTS TO CONTINUE BUSINESS


