Article IV
Duration

Section 4.1. Duration. This existence of this limited liability company shall commence on the date these Articles are executed. This limited liability company shall terminate on the date set forth in its Operating Agreement.

Operating Agreement

Section 9.1. Operating Agreement. The initial Operating Agreement of this limited liability company shall be adopted by the members. The Operating Agreement shall be adopted, altered, amended or repealed from time to time as provided in the Operating Agreement.

Article X
Amendment
