## ARTICLES OF ORGANIZATION OF TUPELO MITIGATION COMPANY, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I: Name

The name of the limited liability company is TUPELO MITIGATION COMPANY, L.L.C. (the Company).

#### ARTICLE II: Address

The mailing address and street address of the principal office of the Limited Liability Company is 550 Greensboro Avenue, Suite 507, Tuscaloosa, AL 35401.

#### ARTICLE VII: Admission and Withdrawal of Members

Except as otherwise provided herein and in the Operating Agreement, the Operating Agreement and these Articles of Organization may be amended from time to time with the written consent of a majority in interest of the members, provided, however, that Articles VII and VIII of these Articles of Organization may be amended only upon the unanimous consent of all the members.
