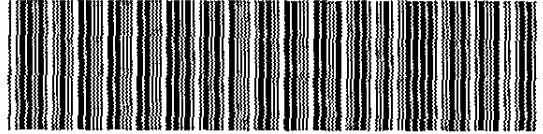

ARTICLE III-REGISTERED OFFICE AND AGENT



The company shall be a manager-managed company.


