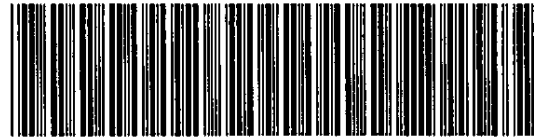


Pursuant to the provisions of the Florida Statutes, this limited liability company adopts the following Amendments to its Articles of Organization:


