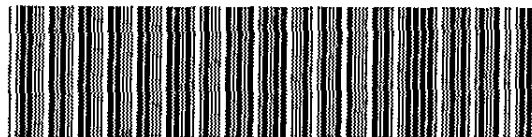

LIMITED POWER OF ATTORNEY
