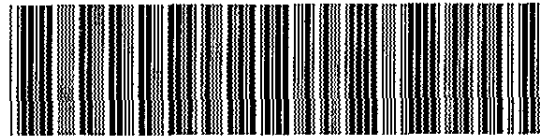

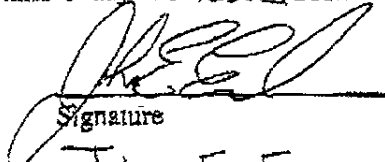

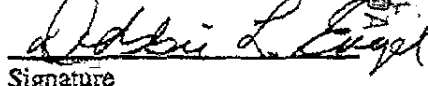
LIMITED POWER OF ATTORNEY

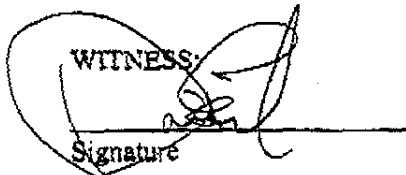
