A Florida Limited Liability Company

- Name. The name of this limited liability company is Tiger 1, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

- Certificated Interests. The members' interests in the Company may be evidenced by certificates.
