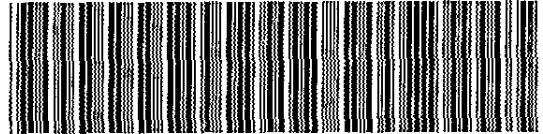

for

Article One – Name
