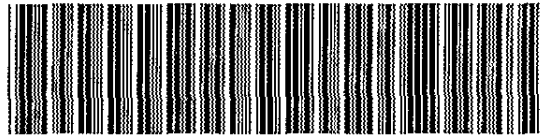



ARTICLE SIX - ADMISSION OF NEW MEMBERS



ARTICLE SEVEN - RIGHT TO CONTINUE BUSINESS


