ARTICLE II - ADDRESS

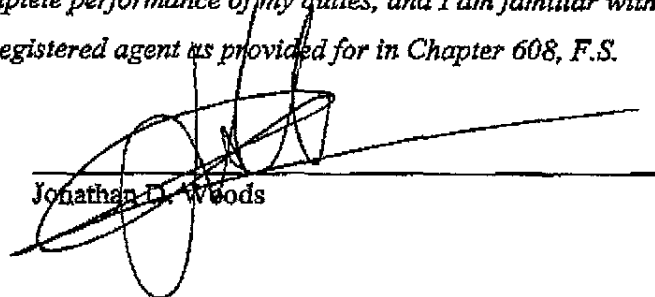

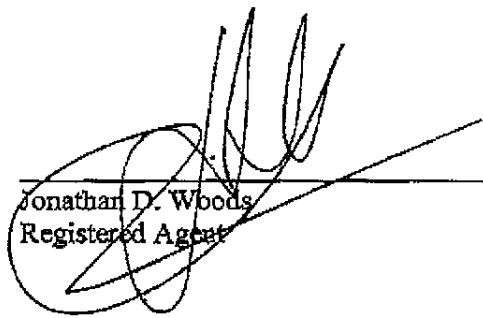
