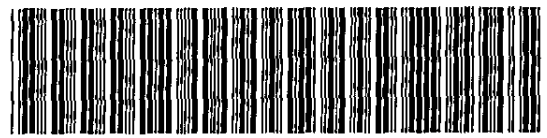

THIRD: Pursuant to Section 608.441, Florida Statutes, all of the members of the limited liability company have provided written consent to have the limited liability company dissolved.





FOURTH: All debts, obligations and liabilities of the limited liability company have been paid or discharged.
