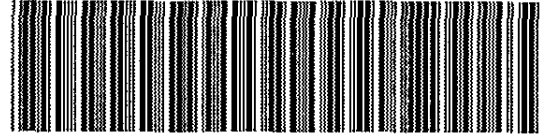

The undersigned hereby certify that we have associated ourselves for the purpose of forming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall be the Charter and authority for the conduct of business of such Limited Liability Company.

ARTICLE I - NAME

The name of the company is Avenue Arts, L.L.C. (the "Company").

ARTICLE II - ADDRESS OF PLACE OF BUSINESS

Members may admit additional Members upon the unanimous agreement of the then existing Members. Contributions required of new members shall be determined as of the time of admission to the Limited Liability Company. A member's interest in the Limited Liability Company may be sold or otherwise transferred but only as provided in the Regulations.

ARTICLE V - MANAGEMENT
