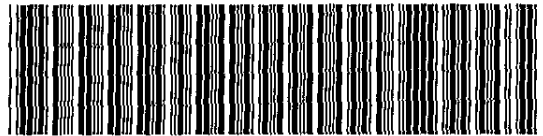

FIRST: The name and address of this corporation is **LPL SERVICES, LLC**, 146 West Sunrise Avenue, Coral Gables, Florida 33133.


SECOND: The date of the adoption of these Articles of Dissolution is 7 February 2003.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
