

ARTICLES OF ORGANIZATION

FOR

SEVENTY-NINTH STREET DEVELOPMENT COMPANY, L.L.C.

ARTICLE VI

Management of Business

The Company shall be managed by a Manager or Managers. Mapes & Mapes, Inc., 525 8th Street West, Bradenton, FL 34205, and Jeffrey Ellard Wilson, 1281 Gulf of Mexico Drive, #1006. Longboat Key, FL 34228, will serve as Managers of the Company until their successors are elected and qualified as provided in the Operating Agreement. These Articles may be amended or restated at any time by the unanimous vote or consent of the Class A and Class B Members, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Act.

ARTICLE XII

Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth therein.


