# ARTICLES OF ORGANIZATION OF BLUE DOLPHIN, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be Blue Dolphin, L.L.C. ("Company").

#### **ARTICLE II - ADDRESS**

#### ARTICLE VI - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except in accordance with the terms and conditions of the operating agreement. A member may transfer his or her interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless the transfer of said interest is in accordance with the operating agreement.
