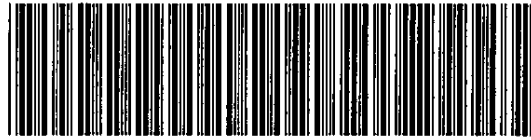

Pursuant to the relevant provisions of Florida Statutes, this Florida limited liability company adopts the following amendment(s) to its Articles of Organization:

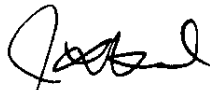
FIRST: The date of filing of the Articles of Organization was October 31, 2002. The assigned document number is L02000029115.
