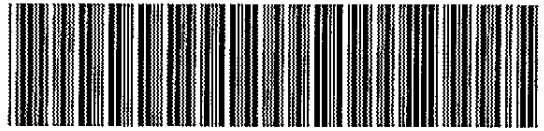

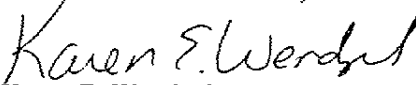

ARTICLE III - DURATION

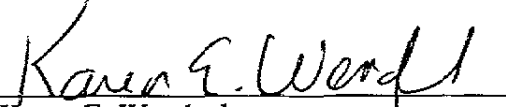
The period of duration for eTrucker.US, LLC shall be perpetual commencing on the date of filing of these Articles of Organization with the Florida Secretary of State.

Additional members may be admitted to eTrucker.US, LLC only upon the unanimous written consent of the existing members.

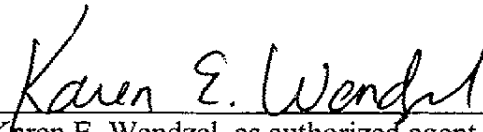
ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS
