ARTICLE I - Name

The name of this limited liability company shall be ENDURING ENTERPRISES, LLC.

ARTICLE II - Duration

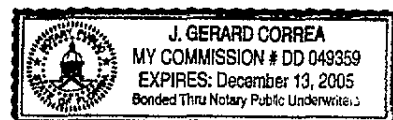


