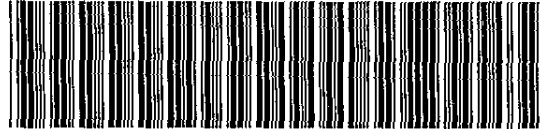

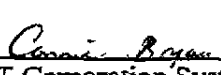
FIRST. The name of the limited liability company is Marina Partners LLC (the "Company").

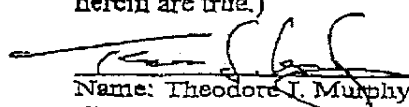
