ARTICLES OF ORGANIZATION

OF

NEXT TRADE GROUP, LC

The undersigned, for the purpose of forming a limited liability company under the liability Company Act. Florida Statutes Chapter 608, hereby Flerke, the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby Ref acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be NEXT TRADE GROUP, LC, ("Company").
