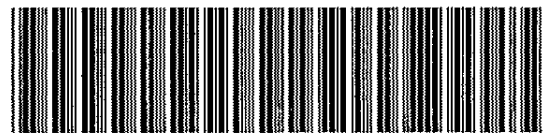



LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is executed on this 5<sup>th</sup> day of November, 2002.




