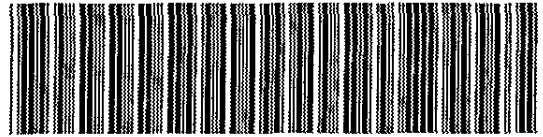

**ARTICLES OF ORGANIZATION
FOR
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned person, acting as an organizer of a limited liability company under the Florida Limited Liability Company Statutory Provisions, hereby adopts the following articles of organization:

ARTICLE I

1. **Name.** The name of this limited liability company is "Games & Things, LLC."

ARTICLE II - Address:

The mailing address and street address of the principal office of the Limited Liability Company is:

ARTICLE III - Duration:

The LLC's period of duration is seventy five (75) years from the date of filing the articles of organization with the Florida Secretary of State, unless sooner dissolved by the members or as provided by statute.

A Class B interest can become a Class A interest only upon the terms and conditions set forth in the operating agreement.


