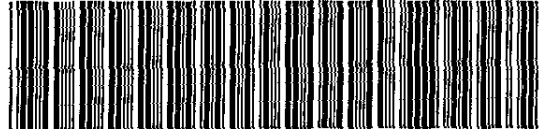

ARTICLES OF ORGANIZATION OF SR Properties, LLC
