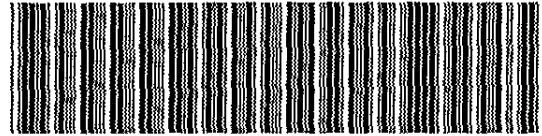



ARTICLE V


Admission of Additional Members; and Terms and Conditions of such Admissions
