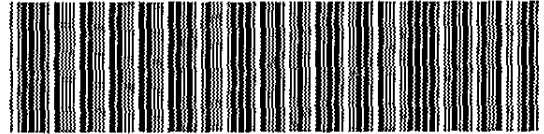

ARTICLES OF ORGANIZATION OF

ARTICLE I -- Name:

the Personal Representative, Testamentary Trustees, Trustees under any Living Trust of the Member, Trustees in Bankruptcy, Heirs, Successors and Assigns of that one member shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the right of a member to continue membership in the limited liability company.

ARTICLE VIII -- Limitation on Agency Authority of Members

Pursuant to Section 608.4235(2)(a) of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.


