The mailing address and street address of the principal office of the Company is 211 N.E. 65 Street, Ft. Lauderdale, Florida 33308.

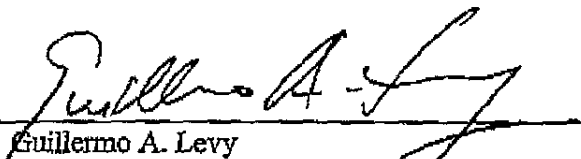
**ARTICLE III
