AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BANANA BAY INVESTMENTS, LLC

These Amended and Restated Articles of Organization ("Amended and Restated Articles") are based upon the following premises:

- A. The Company was originally organized as a member-managed limited liability company for the purpose of investment with its members being Hassan M. Tehrani (a/k/a H. T. Tehrani) and Del Lee.
- B. On or about April 20, 2003 H. T. Tehrani and Del Lee withdrew as members and Narhet LLC became the sole member of the Company. Accordingly, on August 20, 2003 an amendment to the Articles of Organization was filed substituting Narhet LLC ("Narhet") as the managing member and changing the name of the Company to Banana Bay Investments LLC. At the time, the members of Narhet were Hassan M. Tehrani, Kianoosh Tehrani and Dariush Tehrani.
- C. On or about November 5, 2003 Kianoosh Tehrani and Dariush Tehrani withdrew as members of Narhet. In addition, shortly thereafter the membership in Nahret changed as follows:

NAME

BUSINESS PURPOSE

The purpose of the Company is to engage in any lawful act or activity for which a limited liability company may be organized under Chapter 608 of the Florida Statutes.

The Company will be managed by a manager. The initial manager is the Hassan M. Tehrani Irrevocable Trust. Compensation of the manager for agreeing to serve as manager includes, but is not limited to, a 10% membership interest in the Company.

This Company is managed exclusively by a manager, and members have no authority to bind it.

RESTRICTIONS ON TRANSFER OF MEMBERSHIP INTEREST
