### **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be **COLLEGE PARK FINANCIAL GROUP, LLC**, ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 715 Maxwell Street, Orlando, Florida 32804 and the mailing address shall be the same.

#### ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT




