ARTICLES OF ORGANIZATION

OF

PACKT, LLC

The undersigned acting as the organizer of PACKT, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopt the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is PACKT, LLC (the "Company").
