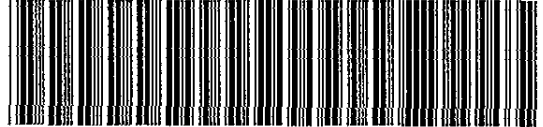

**ARTICLES OF ORGANIZATION FOR
ALL STAR FINANCIAL, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be **ALL STAR FINANCIAL, L.L.C.**

2. Duration/Continuation. 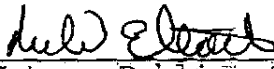
