#### ARTICLES OF ORGANIZATION OF NGG POINT, L.L.C.

#### ARTICLE I NAME

The name of this Limited Liability Company shall be NGG POINT, L.L.C., (the "Company").

#### ARTICLE II DURATION

#### ARTICLE VII NEW MEMBERS
