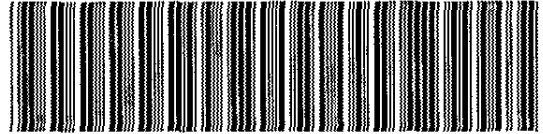

ARTICLES OF ORGANIZATION

The general purpose for which the Company is organized is to engage in the business of the development operation, commercialization, license and administration of programs and computer systems and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 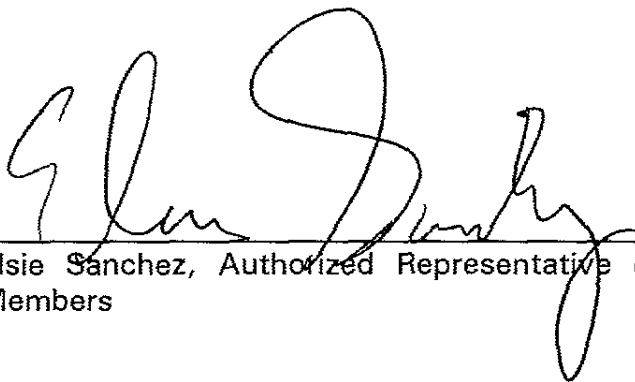

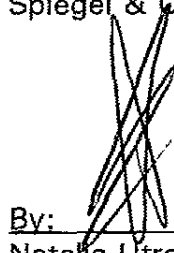
