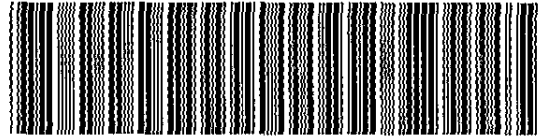

**ARTICLES OF ORGANIZATION
FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - NAME

The name of the Limited Liability Company shall be Evans, Thomas and Thomas, L.L.C.

ARTICLE IV - VOTING

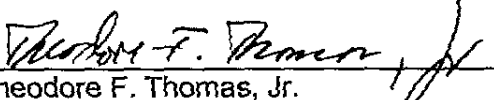
