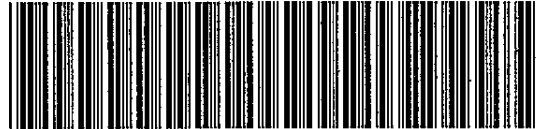

TO
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 608.411, Florida Statutes, this Sarasota Fine Cars, LLC ("Company") adopts the following Articles of Amendment to its Articles of Organization:
