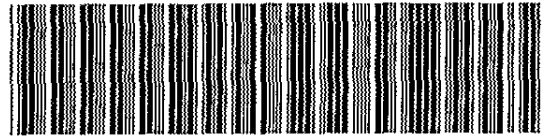

The name of the limited liability company shall be TEAMCO SUPPLIES, L.L.C., ("company").


ARTICLE II - ADDRESS


ARTICLE IV - MANAGEMENT


