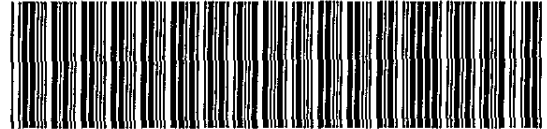



The undersigned person, acting as an organizer of a limited liability company, hereby adopts the following articles of organization:

ARTICLE I

1. **Name.** The name of this limited liability company is "**The Money Pot, LLC.**"

ARTICLE II - Address:

The mailing address and street address of the principal office of the Limited Liability Company is:

ARTICLE III - Duration:

The LLC's period of duration is seventy five (75) years from the date of filing the articles of organization with the Florida Secretary of State, unless sooner dissolved by the members or as provided by statute.

ARTICLE IV - Management:

1. **Manager Managed.** The Limited Liability Company is to be managed by a manager. The name and address of such manager is:

2. **Classes of Ownership and Management.** There shall be two classes of ownership issues in this company. Class A ownership interest shall have economic returns and the exclusive management rights of the company. Class B shall have only economic returns. A Class B interest can become a Class A interest only upon the terms and conditions set forth in the operating agreement.

ARTICLE V - Admission of Additional Members:

Admission of Additional Members. Additional members may be admitted only if they are related by blood or marriage to the existing members.

ARTICLE VI – Withdrawal of Members:


Members. No member can withdraw from this limited liability company until the time stated in the operating agreement or the termination of the entity and the conclusion of its winding down.


