**ARTICLES OF ORGANIZATION FOR  
J.M.O. HOLDING, LLC.  
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be **J.M.O. HOLDING, LLC.**
2. **ADDRESS OF COMPANY.** The mailing and street address of the principal office of the Company is **4525 NW8th Avenue, Oakland Park, Florida 33309.**
