

ARTICLES OF ORGANIZATION OF MIAMI WARBIRDS, L.L.C.

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS OF BUSINESS

privileges and immunities of limited liability companies for profit.

6. To do anything necessary, proper, advisable or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidentally or pertaining to, or going out of, or connected with, its businesses, operations, or powers, provided the same shall not be inconsistent with the laws of the State of Florida.

The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They should be regarded as independent purposes and powers.

Nothing contained in these Articles shall be deemed or construed as authorized or permitting, or purporting to authorize or permit the limited liability company to carry on any business, enterprise, operation, purpose, exercise any power, or do any act which a limited liability company may not, under Florida laws, lawful carry on, exercise, or do.

ARTICLE III EXERCISE OF POWERS

ARTICLE IV MEMBERSHIP RESTRICTIONS
