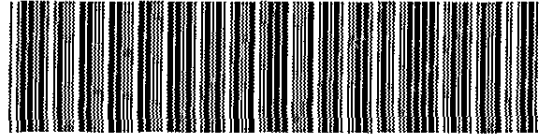

Articles of Organization of TAMRON INVESTMENTS, L.L.C.

The undersigned hereby enter into these Articles of Organization of a Limited Liability Company, by RONALD D. ROBINSON and TAMRA ROBINSON, and pursuant to Chapter 608, Florida Statutes, hereby organize **TAMRON INVESTMENTS, L.L.C.** and further agree:

ARTICLE I

The name of the Limited Liability Company is **TAMRON INVESTMENTS, L.L.C.**

ARTICLE II

These Articles of Organization shall be effective upon filing with the Florida Department of State.

ARTICLE III

The Limited Liability Company is organized for the purposes as follows:

- (a) To engage in the ownership, management and rental of properties, both residential and commercial;
- (b) To deal generally with members of the public to provide residences, apartments, offices and warehouses for periodic terms;
- (c) To perform fully any agreement with any Member of the Limited Liability Company;
- (d) To develop, improve, construct and rehabilitate properties;
- (e) To invest in various investments, including real estate, improved and unimproved, accounts, loans, mortgages, equities and bonds;

(f) To have all of the powers of Limited Liability Companies generally organized and existing under Chapter 608, Florida Statutes or such powers as shall hereafter be conferred upon such companies by the laws of the State of Florida.

ARTICLE IV

The Limited Liability Company initially shall have one place of business and its registered office and mailing address shall be 3741 SW Haines Street, Port St. Lucie, Florida 34953. Its initial registered agent shall be TAMRA ROBINSON at 3741 SW Haines Street, Port St. Lucie, Florida 34953.

ARTICLE V

The total amount of cash and agreed upon value of property other than cash contributed to the Company is as follows:

Additional contributions are not contemplated or required, but may be made at anytime as agreed by the Members.

ARTICLE VI

Additional Members may be admitted upon such terms, conditions, agreements and understandings as shall be agreed upon by the Members including contributions to capital or future contributions of capital. No new Member whether by acquisition of a capital position or acquisition in whole or in part of another Member's interest in the Company shall be allowed except upon the mutual consent and agreement of each Member to the proposed transfer or assignment or entry which consent shall be in writing; provided, however, that even lacking such unanimous written consent, such

management and affairs of the Company or to become a Member with full rights, shall be entitled to the share of profits or other income or return of contributions to which such person would otherwise be entitled based upon the proportionate share of capital of such person.

ARTICLE VII

Upon the death, retirement or resignation of an individual or the bankruptcy, expulsion or dissolution of a Member which is a corporate association or trust, or the occurrence of any other event which terminates the continued Membership of a Member in the Company, the Company shall continue business unless a majority in interest of all of the remaining Members determine, in writing, to terminate the Company, in which event Articles of Dissolution shall be prepared and filed.

ARTICLE VIII

The Company shall be managed by a manager or managers which shall be selected by the Members on an annual basis and which manager or managers shall continue in such capacity until their successor(s) are duly elected and qualified and assume their duties. The initial manager who shall serve until the first annual meeting of or until his successor is elected and qualified is: TAMRA ROBINSON at 3741 SW Haines Street, Port St. Lucie, Florida 34953.

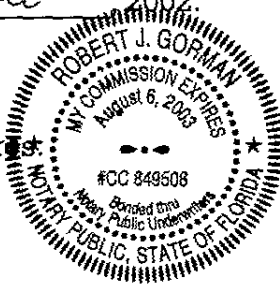
