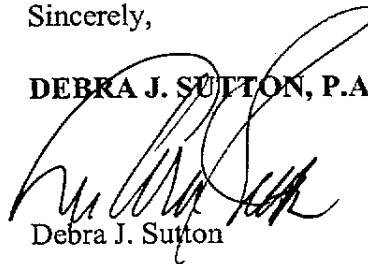

ARTICLES OF ORGANIZATION

The undersigned hereby associate themselves together for the purpose of forming and becoming a limited liability company under the Florida Limited Liability Company Act, under the laws of the State of Florida, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company shall be **SKS INVESTMENTS, L.L.C.** ("company"). The principal place of business of the Company in Florida shall be 325 West Main Street, Bartow, Polk County, Florida.

ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.

ARTICLE III - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member of the Company shall make additional capital contributes to the Company only upon the unanimous consent of all the members.

ARTICLE VII - ADMISSION OF NEW MEMBERS

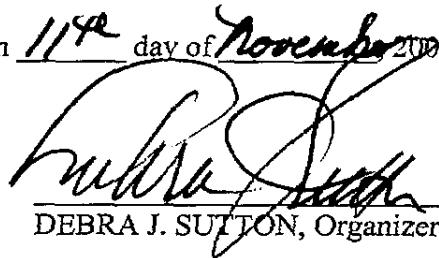
The Company's existence shall be dissolved as provided in these Articles of Organization and the Laws of the State of Florida.

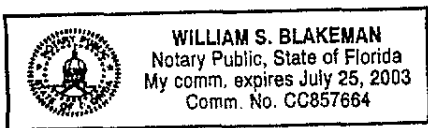

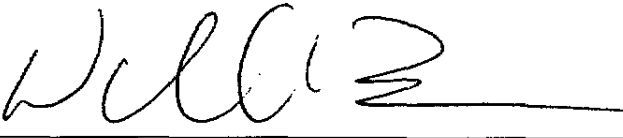

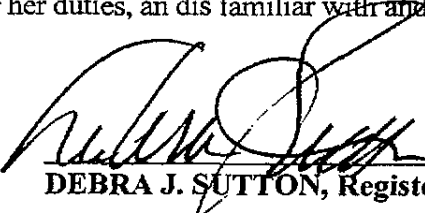
