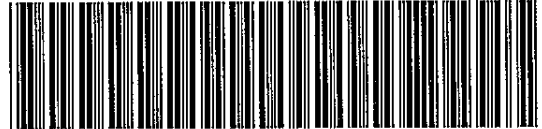

FIRST: The date of the filing of the Articles of Organization was 15 November 2002.


SECOND: The name of this Company shall be changed to **AFG ANDRE FINANCIAL GROUP, LLC**.
