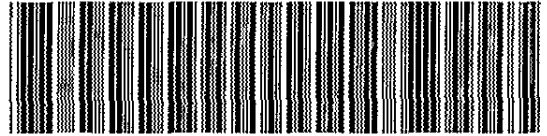

ARTICLES OF ORGANIZATION

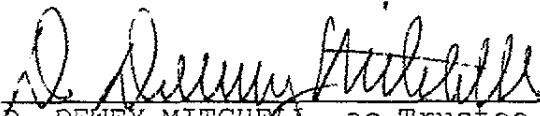
ARTICLE VI.
