2. The Amendment to the existing Articles of Organization being effected hereby is that resulting from completely deleting Article 1 of the Articles of Organization as of the date hereof, and by substituting in its place the Article set forth below.

3. As amended below, Article 1 of the Articles of Organization has the sole effect of changing the Company's name from "MCFUNBALL ENTERPRISES, LLC" to "IMPACT BUSINESS MAIL & MARKETING, L.L.C." The Amendment to the existing Articles of Organization being effected hereby will make no change in the current capital structure of the Company.

4. This Amendment to the Articles of Organization was approved by a unanimous Written Consent of the Managers and Members of the Company, adopted on June 7, 2006. The number of votes cast for this Amendment by the Managers and Members was sufficient for approval of this Amendment.
