This Article is intended to expand

the ability of the company to conduct business with interested parties, and shall not be construed to invalidate any contract or other transaction that would otherwise be valid under the common and statutory law applicable to it.

ARTICLE 9: AMENDMENT

The power to amend, after or repeal these Articles of Organization as maybe provided in the company's Operating Agreement.

ARTICLE 10: CERTIFICATES

The company has the authority to issue Certificates of Membership to each member evidencing that member's interest in the company. Certificates of Membership shall be signed by a manager or officer of the company.
