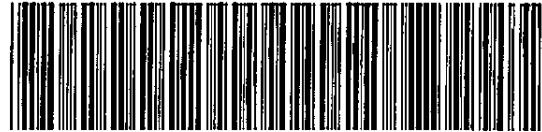



ARTICLE V – DISTRIBUTION OF PROPERTY AND ASSETS


All remaining property and assets have been distributed to the Company’s members in accordance with each member’s respective rights and interest.
