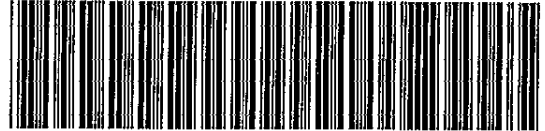

The name of the limited liability company shall be TERNENYI TRUST COMPANY, LLC, ("company").


ARTICLE II - ADDRESS

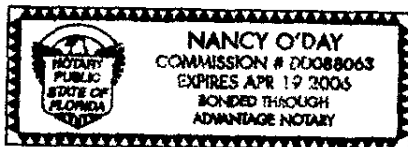
